This is merely a guideline to assist you in determining values for your own items. You must take into consideration the quality and condition of your items when determining a value. **The IRS does not allow Family Service staff to assign a dollar valuation. We can only verify your gift, so be sure to pick up a donation receipt when the goods are dropped off. According to IRS regulations and tax code, clothing and household goods must be in “good condition or better” for tax deductions.**
